The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

I.

The name of the corporation shall be: Family Focus Resource Institute, Inc.

II.

The principal place of business and mailing address of this corporation shall be: The Professional Building Suite 233 126 West Adams Street Jacksonville, Florida 32202

III.

The specific purpose (s) for which the corporation is organized is (are): The corporation is organized pursuant to the Florida Nonprofit Corporation Code. This corporation is a nonprofit public benefit organization and is not organized for the private gain of any person. Its principal strategies of operation will focus on charitable, and educational programs. Its purpose is to promote and establish a full service facility which will provide a complete continuum of care ranging from preventative services to the treatment and rehabilitation of children, youth, and families. The service goals are to provide in-home technical assistance in order to offer quality services in a less restrictive environment, and to provide support services to the court system, and state agencies. The agenda will include, but shall not be limited to: Specialized Parent Education; Preventative Services for Family Violence and Non-Violent Juvenile Offenders; Educational Services for Deprived and Disadvantaged Children; Intensive Crisis Counseling for Crime Victims, Drug Addicted Adults and Teens, HIV Patients, Delinquent and Deprived Children; Providing emergency day care, housing, food, clothing, and furniture for low income families at risk of deprivation. This corporation will coordinate and function in cooperation with Federal, State, County, and local agencies as well as local churches, civic organizations and private business.

IV.

The manner in which the directors are elected or appointed is: The director s shall be appointed and terminated by the initial incorporators according to the Bylaws.

V.

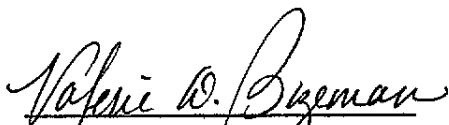

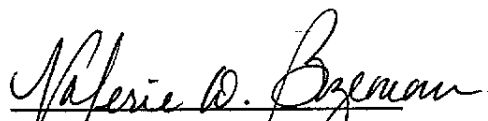
