ARTICLES OF AMENDMENT  
OF THE ARTICLES OF INCORPORATION OF  
THE FLORIDA CANCER EDUCATION NETWORK, INC.

Pursuant to Sections 617.1002 and 607.1006 of the Florida Not for Profit Corporation Act, the Articles of Incorporation of The Florida Cancer Education Network, Inc. (the "Corporation"), are amended according to these Articles of Amendment:

FIRST: The name of the Corporation is The Florida Cancer Education Network, Inc.

SECOND: Article I of the Articles of Incorporation shall be amended in its entirety to read as follows:

"The name of the corporation is: Florida Prostate Cancer Network, Inc."

THIRD: There are no members and foregoing amendment was adopted by all of members of the board of directors of the Corporation effective as of January 31, 2002, the date of execution by the last of the director to sign the written action, constituting a sufficient number of votes for the amendment to be approved in accordance with Sections 617.1006(4) and 617.0821 of the Florida Statutes.
