### Articles of Incorporation

The undersigned Incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

#### ARTICLE I - NAME

The name of the corporation shall be: CHRISTOPHER MOORE MINISTRIES, INCORPORATED

#### <u> ARTICLE II - PRINCIPAL OFFICE</u>

The principal place of business and mailing address of this corporation shall be: PO BOX 3425

LAKE WALES, FLORIDA 33859-3425

#### ARTICLE III - PURPOSES

The specific purposes for which the corporation is organized are:

- 1. To establish and maintain a place for worship.
- 2. To conduct, under the guidance of the Holy Scriptures, the work of evangelism.
- 3. To establish departments for the propagation of the gospel and the support of missionary acts.
- 4. To have the right to own, hold in trust, use or otherwise possess, sell, convey, lease, mortgage, or otherwise dispose of such property, real or chattel, as may be needed for the prosecution of its work.
- 5. The purposes for which the corporation is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.
- 6. Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

# <u> ARTICLE IV - MANNER OF ELECTION OF ELDERS</u>

The manner in which the elders are elected or appointed is:

- 1. The church elders shall be elected at the annual business meeting.
- 2. The elders will be elected by a majority vote cast by the congregation.
- 3. The elders may succeed themselves in office.
