**ARTICLES OF INCORPORATION
OF WORSHIP & THE WORD, INC.**

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation of such corporation:

ARTICLE I

The name of the corporation shall be: Worship & The Word, Inc.

The principal place of business of this corporation shall be: 875 Wilmette Avenue, Ormond Beach, Florida 32174.

ARTICLE II

The period of the duration of this corporation is perpetual unless dissolved according to law. The period shall commence upon filing with the Secretary of State.

ARTICLE III

The purpose for which the corporation is organized is as a Not-For-Profit Christian Fellowship for the advancement of religion, charity, education and any other related or corresponding charitable purposes, including, but not limited to, the establishment of the love of Jesus Christ to everyone on earth and to assist in meeting the physical and spiritual needs of His children.

Further, the corporation is to operate exclusively in any other manner for such religious, charitable and educational purposes as will qualify it as an exempt organization under section 501(c)(3) of the Internal Revenue Code of 1954, as amended, or under any corresponding provisions of any subsequent federal tax laws, covering the distributions to organizations qualified as tax exempt organizations under the Internal Revenue Code, as amended, including public foundations and private foundations.

ARTICLE IV

The qualifications for members and the manner of their admission shall be governed by the Bylaws for this corporation.

ARTICLE V

The number constituting the initial Board of Trustees of the corporation is three, and the names and addresses of the persons who are to serve initially are:

The qualifications for and the manner of appointment of the Trustees shall be governed by the Bylaws for this corporation.

ARTICLE VI

This corporation is organized under a non-stock basis.


ARTICLE VII

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Section 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future law, or to the Federal, State, or Local Government for exclusive public purpose, as determined by the last Board of Trustees.

ARTICLE VIII

The name and address of the incorporator is David P. Sharp, 875 Wilmette Avenue, Ormond Beach, Florida 32174.




