The purposes for which the organization is organized are:

- 1. - 3. To provide planning, training and technical assistance to its members and to these ends to take and hold by bequest, devise, gift, grant, purchase, lease or otherwise any property, real personal, tangible or intangible, or any undivided interest therein, without limitation at to amount or value; to sell, convey, or otherwise dispose of any such property ant to invest, reinvest or deal with the principal or the income thereof in such manner as, in judgement of the directors, will best promote the purpose of the Organization with limitation, except such limitations, if any, as may be contained in the instrument under which is received, the Memorandum of Association, the Articles of Association, or any laws applicable thereto.
- 4. To do any other act, not limited to commerce, or thing incidental to or connected with the foregoing purpose or in advancement thereof.
