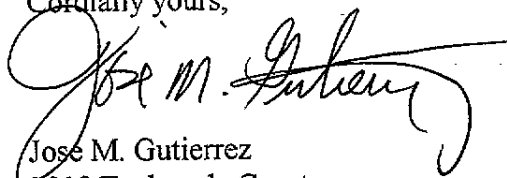

ARTICLES OF INCORPORATION
OF

We, the undersigned incorporators, hereby associate ourselves and make, subscribe, acknowledge and file with the Secretary of State of Florida these Articles of Incorporation for the purposes of forming a Corporation Not-for-Profit pursuant to Chapter 617 of the Florida State Statutes.

ARTICLE I - NAME AND GEOGRAPHIC AREA

I. 1. The name of this corporation is THE HOUR OF MIRACLES, JESUS LOVES YOU, INC. (LA HORA DE MILAGROS, JESUCRISTO TE AMA, INC.) 7818 Esplande Court
Orlando, FL 32836

I. 2. The headquarters of this organization will be in the State of Florida within the central part of the State.

ARTICLE II - PURPOSES AND OBJECTIVES

II. 1. The purposes and objectives for which the Corporation is formed are as follows:

- A. To render Christian guidance, assistance, and education through administering the Gospel to all people.
- B. To participate in and aid organizations that are involved in Christian outreach and evangelism.
- C. To acquire, either by gift or purchase, any real estate or personal property to be held in trust for the benefit of the Corporation and its stated purposes.
- D. To mortgage, sell, or otherwise encumber any such property when such action is deemed to be in the best interest of the Corporation as defined in its stated purposes as a Christian organization.

ARTICLE III - POWERS

III. 1. To accomplish the foregoing purposes, the Corporation will have all corporate powers permitted under the Florida Law, including the capacity to contact, bring suit or be sued.

III. 2. No part of the income of the Corporation will be distributed to the members, directors, and officers of the Corporation.

III. 3. The Corporation is specifically precluded from engaging in any prohibited activities as defined in Section 617.0105, Florida Statutes.

ARTICLE IV - MEMBERSHIP

IV. 1. The membership of this Corporation will constitute of all persons hereinafter named as officers, directors, and other person of good moral character that from time to time may become members by a majority vote of the Board of Directors. Further members of this Corporation will be subject to, or unless:

- A. A vacancy occurs.
- B. The entire Board of Directors feels that the work of the Corporation deems it necessary to open the membership.
- D. An individual petitions for membership.

ARTICLE V - PERIOD OF DURATION

V. 1. The corporation will have perpetual existence.

ARTICLE VI - SUBSCRIBERS

VI. 1. The names and residence of the subscribers of this Corporation are as follows:

ARTICLE VII - OFFICERS (DIRECTORS)

VIII. 1. The names of the directors who will serve until the first election is held are as follows.

President and Treasurer:	Jose M. Gutierrez
Vice-president	Genoveva Gutierrez
Secretary:	Doris Morell

ARTICLE VIII - BYLAWS

VIII. 1. The bylaws of the Corporation may be made, altered, amended or rescinded by vote of a majority of the members of the Board of Directors present at a regular meeting of such Board or at a special meeting called for such purposes.

2. The directors will be elected once a year as stated in the bylaws.

ARTICLE IX - AMENDMENTS

IX. 1. Amendments to the Articles of Incorporation may be proposed and adopted by vote of majority of the members of the Board of directors present at a regular meeting of such Board or at a special meeting called for such purposes.

ARTICLE X - MANAGEMENT OF CORPORATION AFFAIRS

X. 1. The power of this Corporation will be exercised, its properties controlled, its affairs conducted, and its Christian guidance, assistance and education will be managed and governed by the Board of Directors.

X. 2. The number of Directors will initially be three (3) and the number of Directors may be increased from time to time by the By-Laws as deemed indispensable, but will never be less than three (3).

ARTICLE XI - DISSOLUTION AND LIMITATION

XI. 1. In the event of a dissolution, the residual assets of the organization will be turned over

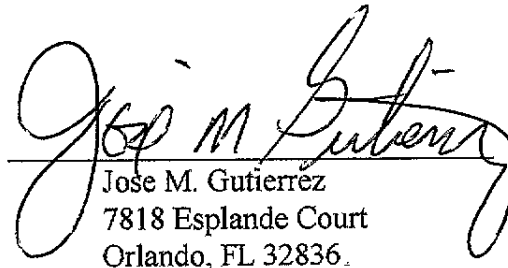
to one or more organization which they are exempt as organizations described in Section 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future law, or to the Federal, State or Local Government's for exclusive public purposes.

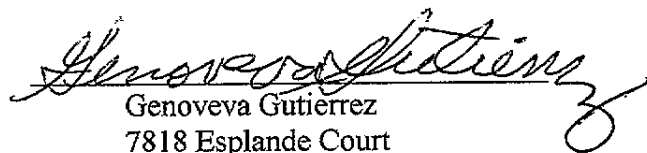
XI. 2. Notwithstanding any other provision of these Articles, this Corporation will not carry on any other activities that are not permitted to be carried on by (a) a corporation exempt from Federal Income tax under Section 501(c) of the Internal Revenue Code of 1954 or corresponding provision of any future United States Internal Revenue law or (b) a corporation, contributions to which are deductible under Section 170(c)(2) if the Internal Revenue Code of 1954 or any other corresponding provision of any future United States Internal Revenue law.

XI. 3. Notwithstanding any other provision of this Article, these purposes are limited to those described in Section 501(c)(3) of the Internal Revenue Code of 1954 or any other corresponding provision of any future United States Internal Revenue law.

XI. 4. In the event of a dissolution, no part of the Corporation's assets will inure to benefit any officer, director or member of the Corporation.
