The undersigned incorporator, for the purpose of forming a corporation under the Florida Not-For-Profit Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation shall be SPIRIT OF YOUTH BASEBALL, INC.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of the corporation shall be 442-10th Avenue, Vero Beach, Florida 32962.

ARTICLE III - PURPOSES
