Articles of Incorporation

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

Article I: Name

The name of the corporation shall be the Radha Krishna Mandir and Yoga Center, Inc.

Article II: Principle Office

The principle place of business and mailing address of this corporation shall be:

372 Araquay Ave
St. Augustine, Florida 32095

Article III: Purposes

The specific purposes for which this corporation is organized are:

1. To systematically propagate spiritual knowledge to society at large and to educate all peoples in the techniques of spiritual life in order to check the imbalance of values in life and to achieve real unity and peace in the world.
2. To propagate a consciousness of Krishna, as it is revealed in the Vedic literatures as represented by the writings and teachings of His Divine Grace A.C. Bhaktivedanta Swami Prabhupada.
3. To bring the members of the corporation together with each other and nearer to Krishna, the prime entity, thus developing the idea within the members, and humanity at large, that each soul is part and parcel of the quality of Godhead (Krishna)
4. To teach and encourage the *sankirtana* movement, congregational chanting of the holy names of God, as revealed in the teachings of Lord Sri Caitanya Mahāprabhu and brought to the western world by His Divine Grace A.C. Bhaktivedanta Swami Prabhupada.
5. To develop facilities for the members and humanity at large that will enhance their practice of *bhakti yoga* as taught by His Divine Grace A.C. Bhaktivedanta Swami Prabhupada.
6. To bring the members closer together for the purpose of teaching a simpler, more natural way of life.
7. With a view towards achieving the aforementioned purposes, to publish and distribute periodicals, books, other writings, especially those of His Divine Grace A.C. Bhaktivedanta Swami Prabhupada; to distribute sanctified foodstuffs (*prasadam*), and other materials and paraphernalia for the practice of *bhakti yoga* and the remembrance of Lord Krishna.

Article IV: Election of Directors

The manner of election of directors: The directors shall be elected for a period of one year at an annual meeting of all members for the purpose of such election. Each member will have one vote and will choose from a list of candidates who are nominated and seconded. Any member can nominate and/or second a candidate.




