ARTICILES OF ADMENDMENT TO ARTICLES OF INCORPORATION OF THE FLORIDA GUARD ASSOCIATION

- D. Perform other missions as assigned bt the Adjutant General and the Governor of the State of Florida
- E. Be prepared to assume the state missions of all of the other components of the Organized Militia upon their federalization.
- F. Furnish aid to civil authorities in the event of disaster, emergency, or domestic disturbance.
- G. To provide military assistance to the Florida State Office of Disaster Preparedness.
- 2. The Florida Guard Association will accomplish the above pruposes by recruiting, train and organize local units of volunteers to be available as a community service.
- 3. The Florida Guard Association will not be associated in any way with any political campaigns nor publish or distribute and publications and political material..
 - All funds received by the organization that are donations will be used for the training of all the personnel to preform the mission as set forth in the purpose of the organization.
 - All funds rfeceived will be used to promote the mission of the Florida State Gaurd Association and no wages will be paid to any individual.
- 4. Upon the dissolution of the corporation, assets shall be distributed to a state of local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of Competent Juristiction of the county in which the principal office of the corporation is then located.
