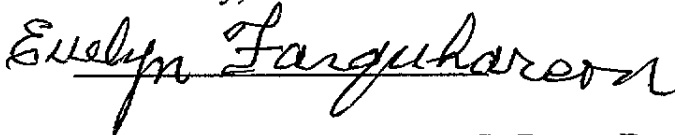

An officer of the corporation may call special meetings of the Directors at any time for any purpose.

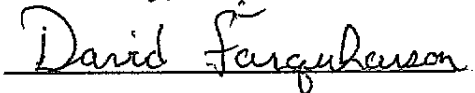

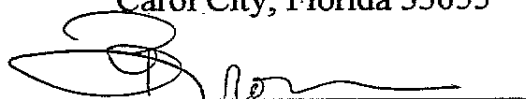
