ARTICLE II Page 2 of 13

Section 3. Supplement

Operate and maintain common property, specifically the surface water management system as permitted by the Southwest Florida Water Management district including all lakes, retention areas, water management areas, ditches, culverts, structures and related appurtenances.

EXIST IN PERPETUITY; however, The Article of Incorporation must provide that if the Association is dissolved, the property consisting of the surface water management system shall conveyed to an appropriate agency of local government, and that if not accepted, then the surface water management system shall be dedicated to a similar non- profit corporation; and, take any other action necessary for the purposes for which the Association is organized.
