

**ARTICLE ONE**

**NAME**

The name of the corporation is **TANGANHUATO VILLAGE FUND, INC.**

**ARTICLE TWO**

**DURATION**

The term of existence of the Corporation is perpetual, and the corporate existence will commence on the filing of these Articles of Incorporation with the Department of State.

**ARTICLE THREE**
