*The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:*

## ARTICLE I - NAME

The name of the corporation shall be: STEPS Christian Family Day Care, Inc.

## ARTICLE II - PRINCIPLE OFFICE

The principle place of business and mailing address of this corporation shall be 2176 San Pablo Court, Middleburg, Florida 32068.

## ARTICLE III - PURPOSES

The specific purposes for which the corporation is organized are:

1. To provide a variety of unique enrichment and learning activities for children.
2. To provide a safe, supervised, learning, environment.
3. To provide love and care in a warm, nurturing, and stimulating environment for children.
4. To meet the individual child's development needs in the social, physical, language, intellectual, creative, and emotional areas.
5. To promote Christian love through prayer, scripture readings, games, dance, drama, and usage of video tapes.



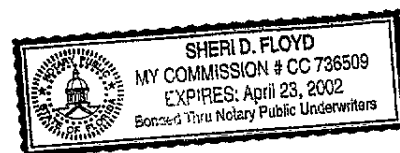


