ARTICLES OF INCORPORATION
OF
NORTH AMERICAN SWAMP RACING ASSOCIATION, INC.

THE UNDERSIGNED, incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation (called the association) is North American Swamp Racing Association, Inc.

ARTICLE II

The association is a non-profit corporation. Its principal place of business and mailing address is 100 Mesa Park Boulevard, Fellsmere, Florida 32948

ARTICLE III

The period of its duration is perpetual.

ARTICLE IV

The specific primary purposes for which the association is formed are to provide for the administration, management, and regulation of racing of motorized vehicles including, but not necessarily limited to swamp/swamp-buggy racing, and to serve as sponsor, endorser or promoter of such and to engage in any and all activities in furtherance of, related to, or incidental to these purposes which may lawfully be carried on by a corporation formed under Chapter 617, Florida Statutes.

ARTICLE V

The street address of the initial registered office of the association is 3355 Ocean Drive, Vero Beach, Florida 32963, and the name of its initial registered agent at such address is Ralph L. Evans.

ARTICLE VI

The manner in which directors are elected or appointed shall be as provided in the By-Laws.

ARTICLE VII

Membership in the Association and all rights pertaining thereto shall be as provided in the By-Laws.


