**ARTICLES OF INCORPORATION
OF THE
STEPHEN BRAGGS YOUTH FOUNDATION, INC.**

We, the undersigned residents of the state of Florida, being eighteen (18) years or more of age, do hereby associate ourselves together for the purpose of forming a Corporation of Public Benefit not-for-profit, under the laws of the state of Florida, pursuant to the following Articles of Incorporation.

ARTICLE 1

Name of Corporation

The name of this Corporation is the Stephen Braggs Youth Foundation, Inc.

ARTICLE 11

Statement of Corporate Nature

This is a not-for-profit Corporation organized solely for the general charitable purposes pursuant to the Florida Corporations not-for-profit Act set forth in chapter 617 of the Florida statutes.

ARTICLE 111

Address of Principle Office

The address of the Principle Office and the Mailing address of the Corporation is as follows: 8047 Golden Glen Court, Orlando, Florida 32819

ARTICLE 1V

General and Specific Purposes

- A. To motivate the youth of a community to learn, to stay in school, to complete one's Education and to continue studying towards college or other advanced levels of Education, either general or vocational or;
- B. To promote good health, good will, interest in participating in athletics and physical Education.

- C. To foster and encourage in the youth of the community, a spirit of loyalty and faith in American traditions and institutions.
- D. To participate actively in constructive movements and endeavors for the promotion and safeguarding of the interest and general welfare of the youth of the community.
- E. To promote the spirit of benevolence, friendship, socialibility, good will and tolerance among the youth in the community.
- F. To perform any and all other lawful things incident and kindered to the above purposes and promote programs of the youth activities.

ARTICLE V **Membership**

Section 1. The corporation shall have active members only

Section 2. All persons of good character who are authorized shall be eligible for active membership

Section 3. No person, otherwise eligible for membership, shall be denied membership in the Stephen Braggs Youth Foundation, because of sex, race, color, creed or Nationality

Section 4. All persons qualified as members shall be admitted in the following manner: by paying annual dues to the Stephen Braggs Youth Foundation in an amount and In the manner provided in the By-Laws. Fifty dollars per year.

ARTICLE XI

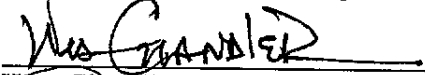
Registered Agent and Registered Office/Principle Office
