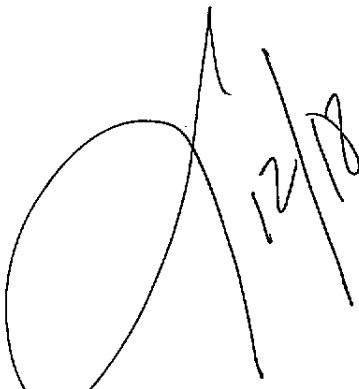

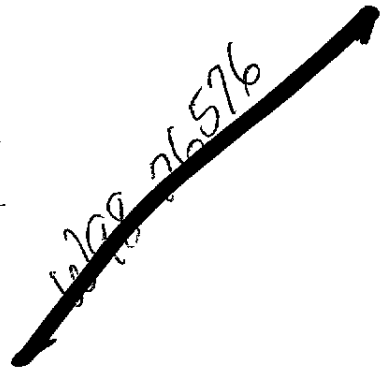

The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a non-profitable corporation under the laws of the State of FLORIDA.

**ARTICLE I - DURATION**

This corporation shall exist perpetually unless dissolved according to FLORIDA Law.

**ARTICLE II - PURPOSE AND NATURE OF CORPORATION**

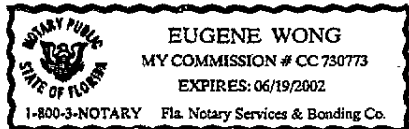
#### ARTICLE VI - AMENDMENT

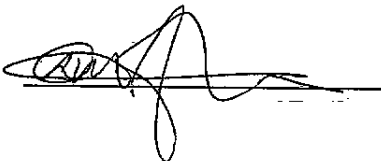
