ARTICLES OF INCORPORATION ANCIENT CITY GAME FISH ASSOCIATION, INC.

A Nonprofit Corporation

ARTICLE I. NAME

The name of the not-for-profit corporation is the Ancient City Game Fish Association, Inc., here-in-after referred to as the Association.

ARTICLE II. OFFICES

The principal office of the Association for the transaction of business shall be located at P.O. Box 2001, in St. Augustine, St. Johns County, Florida. The Association may also have offices at such other places, within or without the State of Florida where it is qualified to do business, as its business may require and as the Board of Directors may from time to time designate.

ARTICLE III. PURPOSE

The purpose of the Corporation is the establishing, maintaining and supervising of an Association designated to carry on recognized programs devoted to promoting the sport of game fishing, conservation of marine natural resources, social functions and other marine activities.

ARTICLE IV. MEMBERSHIP

Section 1. Eligibility

Those eligible for membership in the Association shall be those who profess an interest in the above purposes of the Association and who, in the judgement of the Board of Directors, will share in the responsibilities of the Association and its spirit of good sportsmanship. No person shall be denied membership based on age, race, creed, national origin or sex.

Section 11. Membership

A. This association shall consist of at least one or more natural persons who shall be known as members, membership being available to any natural person professing interest in the purpose of this association. Members shall be admitted by application, in writing to the membership committee established by and under the terms of the by-laws of the corporation. No members shall be entitled to receive any salary or other compensation for services in connection with the administration of the affairs of the corporation, but may be reimbursed for actual, bona fide expenses incurred and authorized by the Board of Directors. Each member shall have one (1) vote. There will be no limit as to the number of members.

ARTICLE V. OFFICERS & BOARD OF DIRECTORS

Section 1. Number

The affairs and business of this corporation shall be conducted and managed by a Board of Directors consisting of a President, Vice President, Secretary, Treasurer, Immediate Past President, and three Directors all of which except the Immediate Past President shall be elected from the floor. The President shall preside at meetings of the Board of Directors and General Meetings. In the event any elected officer is unable to serve his term of office, a new officer shall be elected by the Board of Directors to complete the unexpired term. In the absence of the President, the Vice President shall fulfill the duties of the President. Officers & Directors shall hold office for a period of one year.

Section 2. Duties

- A. The President shall preside at all meetings of the club membership. He shall be ex-officio member of all committees. He shall sign on behalf of the club; all contracts, bonds or other written instruments approved by the Board. He shall retain executive and administrative authority in all matters pertaining to the business of the club in accordance with policies established by the Board.
- B. The Vice President shall assist the President and, in his absence, shall officiate in his stead.
- C. The Secretary shall keep true minutes of the meetings of the general membership and of the meetings of the Board of Directors.
- D. The Treasurer shall collect and receive all funds due and owing the club. He shall pay all bills which are singly or as a class authorized by the Board of Directors.
- E. The Board of Directors shall be charged with the responsibility of managing the association's financial and administrative affairs in the name of and for the benefit of the members.

ARTICLE VI. MEETINGS

Regular monthly meetings shall be held at a time and place appointed by the President.

ARTICLE VII. QUORUM

A quorum of the Board of Directors shall be no less than three officers plus three directors. A quorum for conducting business at any general membership meeting shall consist of no less than two officers and ten members.

ARTICLE VIII. FISCAL YEAR

The first year of this club began on 12/16/98, and ends on May 31, 1999. The accounting period shall end 5/31 on a fiscal year basis.

ARTICLE IX. CONDUCT OF MEETINGS

Roberts Rules of Order, as amended, shall be used to decide all questions of parliamentary procedure.
