ARTICLES OF INCORPORATION

OF

FIPA REGION #13, INC.

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of the Corporation shall be:

FIPA Region #13, Inc.

ARTICLE II. PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business and mailing address of this Corporation shall be:

2691 Jenks Avenue

Panama City, Florida 32405

ARTICLE III. PURPOSES

The purposes for which this Corporation is organized are as follows:

(a) To form an association of physicians capable of responding to the requirements for patient care services of: (1) other health care providers (e.g., hospitals and accountable health partnership), and (2) third party payors (e.g., HMO's insurance companies, employers, and community health purchasing alliances);

(b) to accomplish and effect the foregoing with the overall purpose and objective of providing quality health care services in an accessible, more efficient and cost effective manner;

(c) to take such other actions as will improve the delivery of health care services; and to engage in all actions permissible by law.

ARTICLE IV. INITIAL DIRECTORS AND MANNER OF ELECTION OF DIRECTORS

ARTICLE V. LIMITATIONS OF CORPORATE POWERS

The corporate powers of this Corporation are as provided in Section 617.0302, Florida Statutes.

ARTICLE VIII. MEMBERSHIP

The Corporation shall have a membership separate and distinct from the Board of Directors. The authorized number and qualifications of the members of the corporation, the manner of their admission, the different classes of membership, if any, the property, voting, and other rights and privileges of members shall be set forth in the Bylaws of the Corporation and such other documents as may be adopted by the Board of Directors. Notwithstanding anything to the contrary herein or in the Bylaws of this Corporation, membership in Florida Independent Physicians Association, Inc., a Florida not-for-profit corporation, shall at all times and in all situations be required for membership in this Corporation.

ARTICLE IX. BYLAWS

The power to make, alter, amend, repeal, or adopt Bylaws of this Corporation shall be vested in and reserved to the Board of Directors of the Corporation, as provided for in the Bylaws.

ARTICLE X. AMENDMENT OF ARTICLES OF INCORPORATION

The power to alter, amend, or repeal these Articles of Incorporation shall be vested in and reserved to the members of the Corporation entitled to vote, requiring an affirmative vote of at least 75% of said members.

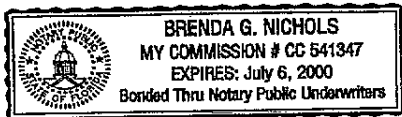
