ARTICLES OF INCORPORATION  
OF

DAVID TEMPLE OF DELIVERANCE, INC.

The undersigned, acting as incorporator of a Corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation for DAVID TEMPLE OF DELIVERANCE, INC.

ARTICLE I  
NAME

The name of this corporation is: DAVID TEMPLE OF DELIVERANCE, INC.

ARTICLE II

The period of the duration of this corporation is perpetual unless dissolved according to law. Corporate existence shall commence upon the date filed with the Department of State.

ARTICLE III

The purposes for which the corporation is organized are for Charitable, Educational, Literary, and Scientific purposes, including for such purposes as making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code of 1954, (or corresponding provision of any future United States Internal Revenue Law).

ARTICLE IV

The membership of this corporation shall constitute all persons hereinafter named as members of said corporation, and such others as from time to time hereafter, may become members in a manner provided in the By-Laws. A two-thirds vote of members present in any regular or special meeting called for in the manner provided in the By-Laws.

STATEMENT OF FAITH: We believe that the Bible is the inspired and infallible Word of God, (II Timothy 2:15-16).

We believe in one God, eternally existent in three persons, which are one; Father, Son (Word), and Holy Ghost, (Deut. 6:4; Matthew 28:19; Mark 12:29; John 5:19-47; John 14: 6/16-17/26/15:26/16:7-16/17:4-5/24; Ephesians 4:4-6; I John 5:7-8; Rev

5:1-14).

We believe in salvation through the blood of Jesus Christ, (I John 5:10; Rom 10:9-17; John 3:14-21; John 12:32).

We believe in water baptism by immersion, in the name of the Father and of the Son and of the Holy Ghost, (Matthew 28:18-20).

We believe in the baptism of the Holy Ghost with the evidence of speaking in tongues as the Spirit gives utterance, (Acts 1:4-5; Acts 2:1-4; Acts 4:31-33; Acts 8:1-24, Acts 9:1-19; Acts 10:44-46; Acts 19:1-7; Rom 8:26-27; I Corinthians 14:1-40).

We believe in spiritual gifts working in each believer for the benefit of all, (I Corinthians 12:1-31; Mark 16:15-18).

We believe in the second coming of Christ with the resurrection of the saints, (Matthew 24:29-31; I Corinthians 15:51-58); I Thessalonians 4:12-18; Acts 1:9-11; Rev 1:7; Rev 19:7-21).

We believe in Holy Communion as remembering the Lord Jesus Christ death and as being partakers with/in the resurrection, (John 6:43-58; Matthew 26:17-28; Mark 14:16-24; Luke 22:15-20; I Corinthians 11:24-34).

#### ARTICLE V

The number constituting the initial Board of Directors of the corporation is three and the names and addresses of the persons who are to serve initially. Trustees are elected according to the By-Laws.

#### ARTICLE VI

In the event of dissolution, the residual assets of the

organization will be turned over to one or more organizations which themselves are exempt as organizations described in Section 501 (c)(3) and 170 (c) (2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future law, or to the Federal, State or Local Code. Notwithstanding any other provision of these Articles this corporation shall not carry on any other activities not permitted to be carried on by (a) corporation exempt from Federal Income tax under section 501(c)(3) of the Internal Revenue Code of 1954 the corresponding provision of any future United States Internal Revenue Law (b) a corporation's contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code of 1954 or other corresponding provision of any future United States Internal Revenue Law.
