# **Marriage Policy**

In keeping with our commitment to the veracity of the Scriptures and their application to all areas of faith and practice as stated in this Article, we affirm the following:

A. <u>Marriage</u> – We believe that marriage has been instituted and ordained by God, and that marriage is defined as the exclusive covenantal union of one man and one woman in which such union is a lifetime commitment. A civil government's sanction of a union will be recognized as legitimate marriage by the church only to the extent that it is consistent with the definition of marriage found in these Articles.

B. <u>Human Sexuality</u> – We believe that legitimate sexual relations are exercised solely within marriage. Hence, sexual activities outside of marriage, including but not limited to, adultery, premarital sex, homosexuality, and pedophilia, are inconsistent with the teachings of the Bible and the church. Further, transgender behavior and the creation and/or distribution and/or viewing of pornography are incompatible with the biblical witness.

C. <u>Family</u> – We believe that the roles of husbands, wives, fathers, mothers, and children are clearly stated in the Scriptures, including the principles of discipline, instruction, and correction. When found to conflict with laws and/or social norms, we will follow the biblical principle.

D. <u>Tolerance</u> – We believe that love and respect are due, and to be offered, to all people, as we're all created in the image of God. However, when the Scriptures speak against other philosophies, belief systems, and behaviors, we will be true to the Scriptures and will speak the truth, but will do so in love.

E. <u>Wedding Applicants</u> - All persons desiring to be married at Outreach Evangelistic Pentecostal Church, Inc. or by a member of our pastoral staff shall be required to complete pre-marital counseling with one of our staff members or another minister or pastor acceptable to Outreach Evangelistic Pentecostal Church in its sole discretion. No marriage or other ceremony shall be performed for any couple who are not qualified in accordance with our policies on marriage. The Pastor conducting the pre-marital counseling has discretionary authority to determine if the couple should or should not be married at Outreach Evangelistic Pentecostal Church or by any ministerial staff members. The Pastor shall decide, in his or her discretion but in conformity with these bylaws, whether or not the church will allow the marriage to be held at the church or to be performed by a ministerial staff member and will so advise the couple.
