ARTICLE I

THE NAME AND ADDRESS

The name of the corporation is, **TABERNACLE OUTREACH MINISTRIES, INC.** with a physical address at 1308 Ave K, Apt. A, Haines City, FL. 33844

ARTICLE II

PURPOSE

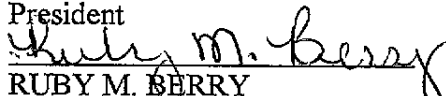
DISTRIBUTION OF ASSETS UPON DISSOLUTION

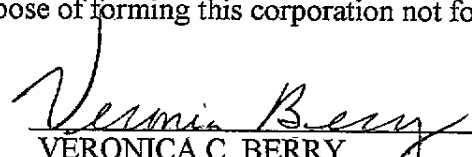
