#### ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

### ARTICLE I

Name

The name of the corporation shall be: The Honduras Disaster Relief Center, Inc.

#### ARTICLE II

Principal place of business and mailing address

The principal place of business and mailing address of this corporation shall be: The Honduras Disaster Relief Center, Inc., 603 Roberts Rise Drive, Ocoee, FL 34761.

## ARTICLE III Purposes

- A. To establish and operate a charitable, humanitarian and educational organization for the purpose of providing relief, aid, assistance and support to the people and non governmental organizations of Honduras, either directly or indirectly, and to provide such relief, aid, assistance and support to other peoples and non governmental organizations when deemed necessary and appropriate by the members of this corporation.
- B. To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations, including without limiting the generality of the foregoing, to acquire by donation, contribution, bequest, devise, gift, purchase, lease or otherwise any property of any sort or nature without limitation as to its amount or value, and to hold, invest, reinvest, manage, use, apply, employ, sell, expend, disburse, lease, mortgage, convey, option, donate or otherwise dispose of such property and the income, principal and proceeds of such property, for any of the purposes set forth herein.
- C. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.

Further, the purposes for which this Corporation is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of section 501(c)(3) of the Internal Revenue Cod of 1986 or the corresponding provision of any future United States Internal Revenue Law.

Notwithstanding any other provision of these Articles, this organization shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Cod of 1986 or the corresponding provision of any future United States Internal Revenue Law.

## ARTICLE IV Manner of election of directors

The manner in which the directors are elected is as stated in the bylaws of the corporation.

### ARTICLE V Limitation of corporate powers

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes.
