



#### ARTICLES OF INCORPORATION

OF

#### FAITH BAPTIST CHURCH OF CHARLOTTE COUNTY, INC.

The undersigned, for the purposes of forming a not for profit corporation under the Florida Not For Profit Corporation Act hereby adopts the following Articles of Incorporation:

## ARTICLE ONE NAME

The name of the not for profit corporation is Faith Baptist Church of Charlotte County, Inc., whose principal office address is 368 Kostner Street, Port Charlotte, Florida 33954.

### ARTICLE TWO DURATION

The term of existence of the not for profit corporation is perpetual and the date and time of the commencement of the not for profit corporation's existence shall be the time of the filing of the Articles of Incorporation by the Department of State.

## ARTICLE THREE PURPOSE

This not for profit corporation shall have as its primary purpose being a Christian organization which provides regular opportunities for the public worship of God, which sustains the ordinances and doctrines of the Church of our Lord Jesus Christ, which teaches and trains its members through a Bible-centered program of Christian education, and which seeks to preach and propagate the Gospel of our Lord Jesus Christ in our local community and throughout the world.

In conducting its affairs so as to maintain its status as a tax exempt organization, as defined by Section 501(c)(3) of the Internal Revenue Code, the not for profit corporation shall comply with the following Sections of the Internal Revenue Code and any Regulations applicable thereto: Sections 170(c)(2); 501(c)(3); 4941(d); 4942; 4943(c); 4944 and 4945(d).

Notwithstanding any other provision of these Articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501(c))3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

#### ARTICLE EIGHT DISSOLUTION

Upon the dissolution of the not for profit corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future Federal Tax Code, or shall be distributed to the federal government, or to a state or local government for a public purpose. Any such asset not so disposed of shall be disposed of by the Circuit Court of the county in which the principle office of the not for profit corporation is then located, exclusively for such purposes or to such organization or organizations as said Court shall determine which are organized and operated exclusively for such purposes.
