**ARTICLES OF AMENDMENT
OF

WHEREAS, FAITH BAPTIST CHURCH OF CHARLOTTE COUNTY, INC., a Florida not for profit corporation, was incorporated under the laws of the State of Florida on December 21, 1998, document number N98000007241; and

WHEREAS, on November 18, 2001, an Amendment to the Articles of Incorporation was adopted, at Special Meeting, by a vote of a majority of the Corporation's members entitled to vote at such meeting, as below, for the purposes of amending Article One; and

WHEREAS, said number of votes cast for the amendment was sufficient for approval under the Articles of Incorporation and By-Laws of the Corporation.

NAME


