The undersigned hereby organizes a corporation not for profit under the provisions of the Florida Business Corporation Act, and pursuant to the following Articles of Incorporation.

ARTICLE 1

Name

The name of this not for profit corporation is: The Everglades Geological Society, Inc.

ARTICLE 2

Mailing Address

The mailing address of this corporation is Post Office Box 61684, Fort Myers, Florida 33906.

ARTICLE 3

Purpose

The objectives of this society are: (1) to stimulate interest and promote advancement in the geosciences; (2) to disseminate and facilitate discussion of geological information; (3) to enhance professional interaction among geoscientists; and (4) to aid and encourage academic training in the geosciences.

ARTICLE 4

Qualifications for Members

The qualifications required for membership and the manner of admission of members shall be as stated and regulated by the Bylaw of the corporation.
