ONE:

The name and address of this principal corporation is Watson's Foundation, Inc., 16183 S.W. 108<sup>th</sup> Avenue, Miami, Florida 33157, in DadeCounty. This corporation is organized pursuant to **FLORIDA** Nonprofit Corporation Code.

TWO:

THREE: The duration of this corporation shall be perpetual, no stock and shall have no members.
