#### ARTICLES OF INCORPORATION

#### FOR

#### KIWANIS CLUB OF CENTRAL PALM BEACH COUNTY, INC. A NOT FOR PROFIT CORPORATION

The undersigned, acting as incorporators of a corporation under Chapter 617, Florida Statutes, adopt the following Articles of Incorporation:

#### ARTICLE I - NAME

The name of the corporation shall be: KIWANIS CLUB OF CENTRAL PALM BEACH COUNTY, INC.

## ARTICLE II - PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business and the mailing address of this corporation shall be: 3228 Gun Club Road, West Palm Beach, Florida 33406.

#### ARTICLE III - PURPOSE

The specific purposes for which the corporation is organized are:

- 1) To give primacy to the human and spiritual rather than to the material values of life.
- 2) To encourage the daily living of the Golden Rule in all human relationships.
- To promote the adoption and the application of higher social, business, and professional standards.
- 4) To develop, by precept and example, a more intelligent, aggressive, and serviceable citizenship.
- 5) To provide through this club, a practical means to form enduring friendships, to render altruistic service, and to build better communities.
- To cooperate in creating and maintaining that sound public opinion and high idealism which make possible the increase of righteousness, justice, patriotism, and good will.
- 7) For the purposes aforesaid, to take over the assets, rights and franchises of the unincorporated club, known as the Kiwanis Club of Central Palm Beach County, and its members.

8) To do all such things as are incidental or conducive to the attainment of the above objects.

#### ARTICLE IV - PERPETUAL EXISTENCE

The existence of this corporation shall be perpetual.

### ARTICLE V - QUALIFICATIONS OF MEMBERS

The qualifications of members and the manner of their admission shall be in accordance with the provisions set forth in the Bylaws.

#### ARTICLE VI - BOARD OF DIRECTORS
