Pursuant to the provisions of Chapter 607 of the Florida Statutes and the Florida Business Corporation Act, the undersigned hereby provides the following amendment to the Articles of Incorporation of **New Song Baptist Church of Tampa, Florida, Inc.**, a Florida corporation (the "Corporation").

1. ARTICLE 1 of the Articles of Incorporation of **New Song Baptist Church of Tampa, Florida, Inc.** is amended to read as follows:
