ARTICLES OF INCORPORATION OF AMERICAN LAW ENFORCEMENT FOUNDATION, INC

SECRETARY OF SIA

The undersigned has executed these Articles for the purpose of forming a corporation not for profit under Chapter 617 of the Florida statutes and certifies as follows.

ARTICLE I

The name of the corporation hereinafter called the "Corporation" shall be: AMERICAN LAW ENFORCEMENT FOUNDATION, INC. with its principal place of business being 1410 U.S. Highway #1, Malabar, FL 32950.

ARTICLE II

The period of the duration of this Corporation is perpetual unless dissolved according to law.

ARTICLE III

The specific and primary purposes for which this Corporation is formed and for which it shall be exclusively administered and operated are to receive, administer and expend funds for charitable and educational purposes in connection with increasing public awareness of the dangers facing law enforcement personnel; providing assistance to injured or disabled police officers; and providing needed equipment to law enforcement departments.

The Corporation shall also engage in and perform any and all acts of a charitable nature to help law enforcement departments and officials by all means, without limitation, as well as to raise funds and acquire products for said purposes.

The Corporation shall further enter into any other lawful endeavor, from time to time and without limitation, except as prohibited by \$501(c)(3) of the Internal Revenue Code of the United States and other appropriate laws, rules and regulations and may assist other charitable, educational and social welfare organizations in the conduct of similar activities;

ARTICLE IV

The registered office of this Corporation and its registered agent to accept service of process within the State of Florida is: Patrick Robert Pata, located at 1410 U.S. Highway #1, Malabar, FL 32950.

ARTICLE V

The Corporation shall not have members.

ARTICLE VI

No part of the net earnings of the Corporation shall inure to the benefit of any member, Director, officer of the Corporation, or any private individual (except that reasonable compensation may be paid for

services rendered to or for the Corporation affecting one or more of its purposes), and no member, Director, officer of the Corporation, or any private individual shall be entitled to share in the distribution of any of the corporate assets upon dissolution of the Corporation. No substantial part of the activities of the Corporation shall be the No substantial part of the activities of the corporation shall influence carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in or intervene in (including the publication or distribution of statements) any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of these Articles, the Corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code and its Regulations as they now exist or as they may hereafter be amended, or by an organization, contributions to which are deductible under Section 170(c)(2) of such Code and Regulations as they now exist or as they may hereafter be amended.

Upon the dissolution of the Corporation or the winding up of it affairs, the assets of the Corporation remaining after payment of all costs and expenses of such dissolution shall be distributed exclusively to charitable, religious, scientific, literary, or educational to charitable, religious, scientific, literary, or educational organizations which would then qualify under the provisions of Section 501(c)(3) of the Internal Revenue Code and its Regulations as they now exist or as they may hereafter be amended, and none of the assets will be distributed to any member, officer or director of the Corporation or to any private individual. or to any private individual.

The affairs, property and business of the Corporation shall be managed and controlled by a Board of Directors consisting of the number of Directors determined by the Bylaws, but not less than two Directors.

Directors of the Corporation shall, at the annual meeting, be elected and hold office in the manner determined by the Bylaws of the Corporation. Directors may be removed and vacancies on the Board of Directors shall be filled in the manner provided in the Bylaws.
