

ARTICLES OF INCORPORATION
OF
AMERICAN LAW ENFORCEMENT FOUNDATION, INC.

The undersigned has executed these Articles for the purpose of forming a corporation not for profit under Chapter 617 of the Florida statutes and certifies as follows.

ARTICLE I

The name of the corporation hereinafter called the "Corporation" shall be: AMERICAN LAW ENFORCEMENT FOUNDATION, INC. with its principal place of business being 1410 U.S. Highway #1, Malabar, FL 32950.

ARTICLE II

The period of the duration of this Corporation is perpetual unless dissolved according to law.

ARTICLE III

The specific and primary purposes for which this Corporation is formed and for which it shall be exclusively administered and operated are to receive, administer and expend funds for charitable and educational purposes in connection with increasing public awareness of the dangers facing law enforcement personnel; providing assistance to injured or disabled police officers; and providing needed equipment to law enforcement departments.

The Corporation shall also engage in and perform any and all acts of a charitable nature to help law enforcement departments and officials by all means, without limitation, as well as to raise funds and acquire products for said purposes.

The Corporation shall further enter into any other lawful endeavor, from time to time and without limitation, except as prohibited by §501(c)(3) of the Internal Revenue Code of the United States and other appropriate laws, rules and regulations and may assist other charitable, educational and social welfare organizations in the conduct of similar activities;

ARTICLE IV

The registered office of this Corporation and its registered agent to accept service of process within the State of Florida is: Patrick Robert Pata, located at 1410 U.S. Highway #1, Malabar, FL 32950.

ARTICLE V

The Corporation shall not have members.

ARTICLE VI

No part of the net earnings of the Corporation shall inure to the benefit of any member, Director, officer of the Corporation, or any private individual (except that reasonable compensation may be paid for

services rendered to or for the Corporation affecting one or more of its purposes), and no member, Director, officer of the Corporation, or any private individual shall be entitled to share in the distribution of any of the corporate assets upon dissolution of the Corporation. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in or intervene in (including the publication or distribution of statements) any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of these Articles, the Corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code and its Regulations as they now exist or as they may hereafter be amended, or by an organization, contributions to which are deductible under Section 170(c)(2) of such Code and Regulations as they now exist or as they may hereafter be amended.

Upon the dissolution of the Corporation or the winding up of its affairs, the assets of the Corporation remaining after payment of all costs and expenses of such dissolution shall be distributed exclusively to charitable, religious, scientific, literary, or educational organizations which would then qualify under the provisions of Section 501(c)(3) of the Internal Revenue Code and its Regulations as they now exist or as they may hereafter be amended, and none of the assets will be distributed to any member, officer or director of the Corporation or to any private individual.

ARTICLE VII

ARTICLE VIII

The affairs, property and business of the Corporation shall be managed and controlled by a Board of Directors consisting of the number of Directors determined by the Bylaws, but not less than two Directors.

Directors of the Corporation shall, at the annual meeting, be elected and hold office in the manner determined by the Bylaws of the Corporation. Directors may be removed and vacancies on the Board of Directors shall be filled in the manner provided in the Bylaws.

ARTICLE IX

The officers of the Corporation shall be the President, Secretary and Treasurer (which may combine with another office as allowed by law), and such other officers as may be provided in the Bylaws of the Corporation.

The officers shall be elected by the Board of Directors at its first meeting and shall serve at the pleasure of the Board of Directors.

ARTICLE X

The Board of Directors of this Corporation shall make, adopt, alter, amend and repeal such Bylaws of the Corporation for the conduct of the business of the Corporation and the carrying out of its purposes as such Directors may deem necessary from time to time. The Bylaws may be altered, amended or repealed at any meeting of the Board of Directors of the Corporation in the manner provided in the Bylaws.

ARTICLE XI

The Corporation shall defend, indemnify and hold harmless, every registered agent, director or officer and his or her heirs, personal representatives and administrators against liability and against expenses reasonably incurred by him or her in connection with any action, suit or proceeding to which he or she may be made a party by reason of his or her having been a director or officer of this Corporation, except in relation to matters as to which he or she shall be finally adjudged in such action, suit or proceeding to be liable for willful misconduct. The foregoing rights shall be exclusive of other rights to which he or she may be entitled.
