ARTICLES OF INCORPORATION
OF
ST. FRANCIS INDEPENDENT CATHOLIC COMMUNITY, INC.

The undersigned, desiring to form a not-for-profit corporation under the Florida Not-For-Profit Corporation Act, Chapter 617, Florida Statutes, do hereby certify:

ARTICLE I - NAME

The name of the corporation is ST. FRANCIS INDEPENDENT CATHOLIC COMMUNITY, INC.

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - PURPOSE

A. This corporation is organized exclusively for charitable purposes. In furtherance of this purpose, this corporation may transact any and all business lawful for a not-for-profit corporation, including but not limited to: providing a setting for all individuals seeking a spiritual path within a free and independent catholic rite without the dogma and formalities of the traditional catholic rites; providing assistance to all people so interested, in developing physical, emotional, mental and spiritual integration in order to attain maximum creativity, health, knowledge, love and peace in the material and spiritual realm; providing a safe place for all people to celebrate God's love; providing spiritual counseling, guidance and healing by priests, ministers and practitioners ordained in major or minor orders of the church.

B. No part of the net earnings of the corporation shall insure to benefit of, or be distributable to, its members, officers or other private persons, except that the corporation shall be authorized in power to pay reasonable compensation for services rendered, and to make payment and distributions in furtherance of the purposes set forth in Paragraph A of this Article. No substantial part of the activities of the corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distributing of statements) any political campaign on behalf of a candidate for public office. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on: (a) by a corporation exempt from federal income tax under 501 (C) (3) of the Internal Revenue Code, or (b) by a corporation, contributions to which are deductible under 170 (C) (2) of the Internal Revenue Codes.

ARTICLE IV - MANNER OF ELECTION OF DIRECTORS

The affairs of the corporation shall be conducted by a Board of Directors consisting of not less than three (3) nor more than nine (9) Directors. Members of the board shall be nominated and voted upon by the those who claim membership in the community that gathers for prayer.

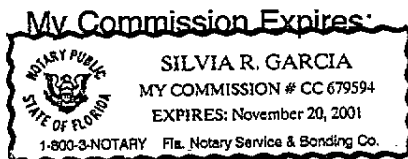

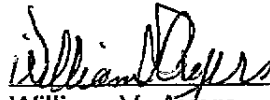

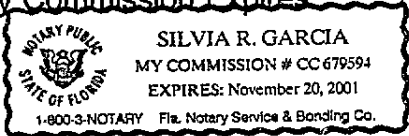
