## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF UNITED CHURCH BUILDERS, INC.

The undersigned directors, for the purpose of Amending the Articles of Incorporation under the Florida Not for Profit Corporation Act. Section 617.1006. Florida Statutes, hereby adopt the following Articles of Amendment to its Articles of Incorporation.

### First: Amendments

The original Articles of Incorporation State of Florida, Division of Corporation document number N 98000007318, are hereby amended to add Article VII providing as follows:

- A. United Church Builders, Inc. is organized exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the making of distributions to organizations under Section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax code).
- B. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, directors, officers or any private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of Section 501(c)(3) purposes. No substantial part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in, (including the publishing or distribution of statements) any political campaign on behalf of, or in opposition to, any candidate for public office.

- C. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on, (a) by a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax code) or, (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code (or corresponding section of any future Federal tax code).
- D. Upon dissolution of this corporation assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future Federal tax code, or shall be distributed to the Federal government, or to a state or local government, for a public purpose.

## Second: Date of Adoption

The date of adoption of the amendments was: May 28, 1999.

### Third: Action by Board of Directors:

- a. There are no members or members entitled to vote on the amendments.
- b. The Board of Directors took action on May 28, 1999, to adopt the amendments set forth herein. The action taken by the Board of Directors was unanimous.
