**ARTICLE I**

The name of the corporation shall be Fast Forward Trak Club, Inc.

**ARTICLE II**

The principal place of business and mailing address of this corporation shall be: Post Office Box 10305, St. Petersburg, Florida 33733-0305.

**ARTICLE III**

The specific(s) for which the corporation is organized is to inspire high academic achievement, positive attitudes, good sportsmanship, healthy lifestyles, and cultural diversity by using the track and field sports arena for youth of all ages in Pinellas County.

Focusing on life changing alternatives through teamwork, self-respect, dignity and individual growth to include all members, parents and surrounding communities.

**ARTICLE IV**

The manner in which the directors are elected or appointed is as follows:

- To be qualified for elected office a member shall have attended one-half of general-purpose meetings in the prior six months and must also meet criteria established by the Board.
- The term of the office shall be from October 1 of the elected year through September of the following year.
- Successful candidates must get a majority of the votes cast for the office.
- Qualified members may be candidates for more than one office, but no person shall hold two elected offices simultaneously. Ties will require that ballots be cast until a winner can be determined.

**ARTICLE V**
