Purpose(s)

The specific purpose(s) for which the corporation is organized is(are): *To encourage evangelism by the proclamation of the Gospel of Jesus Christ to all the world; To further the work of scriptural missions both domestic and global; To cultivate a deeper spirit of fellowship and co-operation among churches; To encourage the process of education, training and discipleship in the Body of Christ; and provide a means through which all affiliate churches may share in these endeavors.*

ARTICLE IV

Manner of election of directors

The manner in which the directors are elected or appointed is as follows:

The ^{directors} officers, (President/Moderator, Vice President/Vice Moderator Clerk/Secretary and Treasurer shall be elected by the delegates of the affiliate churches at the full Annual Meeting to one year terms. There are no term limits for ^{directors} officers except the moderator who may not serve more than two consecutive terms. ³ At large ~~directors~~ ^{directors} will be elected in the same manner to staggered 3 year terms.


