ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION

SECRETARY CF SIALLAHASSEE, FLORIS

GIFTS FOUNDATION, INC.

18 . W.

- 1. The name of the corporation is Gifts Foundation, Inc.
- 2. Article III of the Articles of Incorporation of Gifts Foundation, Inc., a Florida corporation, is hereby amended in its entirety to read as follows:

ARTICLE III - PURPOSE

The organization is organized exclusively for charitable, religious, educational, and/or scientific purposes under section 501 (c)(3) of the Internal Revenue Code.

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution statements) and political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501 (c)(3) of the Internal Revenue

Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution of the organization, asset shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

- 3. The foregoing amendment is adopted by the members of the Board of Directors of the corporation on 5-/9-99, 1999, by written statement and consent, pursuant to Section 6/7.1005, Florida Statutes. There are no members entitled to vote.
- 4. The foregoing amendment shall become effective upon filing with the Secretary of State, State of Florida.
