ARTICLES OF INCORPORATION

OF

ALPHA PREGNANCY CENTER OF PALM COAST, INC.

A FLORIDA NOT FOR PROFIT CORPORATION

Pursuant to the provisions and requirements of Chapter 617, Florida Statutes, and for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, the following Articles of Incorporation are hereby adopted and set forth:

ARTICLE I

The name of this corporation is: Alpha Pregnancy Center of Palm Coast, Inc.

ARTICLE II

The street address of the initial principal office of this corporation shall be 344 Wellington Drive, Palm Coast, Florida, 32164.

The business mailing address of this corporation shall be 344 Wellington Drive, Palm Coast, Florida, 32164.

ARTICLE III

The purposes for which the corporation is organized and shall be exclusively operated are for the teaching and educating people on principles of stewardship of assets for the benefit of the family; to use every lawful means to encourage people to consider all the options concerning pregnancy, abortion and adoption of babies; for counseling and long term support; to teach all men to observe all things whatsoever the Lord Jesus Christ commands; and said purposes include any and all legal purposes for which tax exempt organizations that are described in section 501(c)(3) of the Internal Revenue Code of 1986, as amended, meeting the requirements thereof, may conduct business and qualify as exempt from taxation under section 501(a) of the Internal Revenue Code of 1986, as amended, or corresponding provision of any future United States Internal Revenue law, and for any and all lawful business for which not-for-profit corporations may be incorporated under Florida law in accordance with Chapter 617, Florida Statutes, and may conduct business as a tax exempt organization described in section 501(c)(3) of the Internal Revenue Code of 1986, as amended, meeting the organizational test thereof, and is exempt from taxation under Section 501(a) of the Internal Revenue Code of 1986, as amended.

ARTICLE IV

The board of directors shall be the governing body of the Corporation and shall consist of three or more individuals, with the total number specified in accordance with the by-laws. The initial board of directors shall consist of the three (3) herein named incorporators. The number of directors may be increased or decreased from time to time in the manner provided in the bylaws, but the corporation shall never

have fewer than three directors. The manner in which the directors are elected, or appointed, shall be that method provided for in the by-laws. In the event of resignation, death or refusal to serve or continue to serve of any director, such vacancy shall be filled by majority vote of the remaining directors then serving.

ARTICLE V

The duration of this corporation is perpetual. The date and time of commencement of the corporate existence is the time of filing of the articles of incorporation by the Department of State of the State of Florida.

ARTICLE VI

This corporation is organized under a non-stock basis.

ARTICLE VII

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as a organization described in section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or corresponding sections of any prior or future law, and qualify as exempt from taxation under section 501(a) of the Internal Revenue Code of 1986, as amended, or to the Federal, State, or Local government for exclusive public purpose.

ARTICLE VIII
