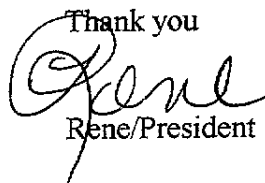

ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

Article One Effective Date of Corporation

The Corporation was established in Aug. 3, 1998 in Lakeland Florida.

Article Two Name

The name of the Corporation is:
Day by Day with Friends, Family and Rene, Inc.

Article Three Principal office and Physical address

The principle office of this corporation shall be located at 1500 West Highlands St. #121 Lakeland Fla., 33815, which is also the physical address of said corporation. However there shall be a mailing address to which all inquires and correspondence must be sent such mailing address shall be as follows. P.O. Box 7581, Lakeland, Fla. 33807

Article Four Purpose

1. Said corporation is organized exclusively for religious and Christian purposed to include but not limited to the making and distributions of newsletters, magazines, books, tapes and any such religious materials as is deemed necessary for the promotion of Christian education.
2. To provide counseling and to help as many people as possible to meet their daily needs and to cope with life's daily demands.
 1. Outreach ministries including:
 - a. Publications
 - b. Performances
 - c. Radio
 - d. Television
 - e. Counseling

Article Five Duration

The term of existence of the Corporation is perpetual; and the corporate existence will commence on the filing of these articles by the Department of State.

Article Six Directors

Article Seven
Appointment of Directors

Section 1 Directors shall be appointed by the President of Day by Day Ministries Inc.

Section 2 Such appointment shall take place at the last business meeting of each year commencing from the initial start date of Day By Day Ministries.

Section 3 New Directors shall take office the first week of the new anniversary year and shall serve until the end of the year.

Section 4 The President reserve the right to terminate or replace and Director at any time as he or she might see fit for the smooth running of the ministry.

Article Eight
Duties of Directors Defined

The president shall have the power to :

- a. manage and oversee the daily operation of the corporation
- b. to make all decision or the authorize someone else to make decision for the corporation.
- c. to hire or terminate employees as the case may be.

Section 2. Vice-President

The Vice - President shall undertake the duties of the President in his or her absence or at anytime so directed by the President.

Section 3. Director

The Director shall undertake the duties of the Vice-President in his or her absence or at anytime so directed by the President. Director also assistance President and Vice President in making all decision.

Article Nine
Members

The corporation shall not have any Members. However, this may change in the future if the Directors chooses. If this becomes necessary their membership shall be voluntary or as is laid down in the by-laws.

Article Ten
Amendment

These articles may be altered or amended by the President as may deemed necessary unless prohibited by the laws of the state of Florida or any other governing body of the United States of America.

Article Eleven
Distribution of Assets upon Dissolution

Distribution of Assets upon Dissolution no person, firm, or association shall ever receive any dividends or profits from the undertaking of this ministry, and upon dissolution of this ministry, all of its assets remaining after payments of all cost and expenses of such dissolution shall be distributed to organizations which have qualified for exemption under section 501 (c) (3) of the Internal Revenue code, or for a public purpose, and none of these assets will be distributed to any officer of this ministry or their relatives.
