ATTACHMENT #1 TO THE ARTICLES OF INCORPORATION FOR JACKSONVILLE VICTORY CHURCH INC.

ARTICLE III: PURPOSES

The Corporation is organized and operated exclusively for religious and charitable purposes in accord with Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United State Internal Revenue law and referred to below as the "Code"). More specifically the purpose of the corporation is to operate a church providing the opportunity for regular religious worship, scripture study and Christian fellowship for church members as well as the general public.

ARTICLE IV: MANNER OF ELECTION OF DIRECTORS

The Church Board shall interview all recommended persons who meet all qualifications of membership and each candidate shall respond to the following questions in a manner satisfactory to the Church Board:

- 1. Are you saved?
- 2. Are you praying for God's blessing on this Church?
- 3. Do you have a desire to seek the salvation of souls?
- 4. Will you agree to abstain from the use of tobacco and intoxicating liquors?
- 5. Are you free from membership in any oathbound secret society?
- 6. Is it your desire to cooperate and assist in the work of this organization to preserve the unity of the Spirit in the bond of peace?
- 7. Do you, without reservation, support the doctrinal statement of this Church?

At the annual meeting of members the Chairperson of the Church Board shall introduce the persons who are seeking to become directors in the Church and who have been qualified by the Church Board. The members of the Church shall then have the opportunity to ask questions in open forum of any and all candidates. After questioning is complete the Chairperson of the Church Board shall request a vote to be taken for director. Candidates shall be elected to the role of director by a plurality of votes cast. Elected Directors shall begin serving the Board upon election.

ARTICLE V LIMITATION OF CORPORATE POWERS

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, unless limited as follows:

1. The power to amend Articles of Incorporation or bylaws is limiting under the consent of the Council of Churches as outlined in the provisions of the bylaws of the Association of Victory Churches.
