**ARTICLES OF INCORPORATION OF
A FLORIDA NOT-FOR-PROFIT CORPORATION**

ARTICLE ONE

NAME

The complete legal name of the Corporation is **WHY ARE THE CHILDREN HURTING?, INC.**

ARTICLE TWO

DURATION

The term of existence of the Corporation is perpetual. The corporate existence will commence on the filing of these articles by the Department of State.

ARTICLE THREE

PURPOSE

The purpose for which the Corporation is organized is to receive, hold, and invest funds or other property from any source, which funds are to be used for the sole benefit of lobbying, instituting initiatives, and petitioning for longer, harsher, and mandatory sentences for sexual offenders and predators, and may also be used for the benefit of the victims of child sexual abuse.

ARTICLE FOUR

DIRECTORS

The Board of Directors of the Corporation shall initially consist of the following members, who will serve until the first election of Directors as provided in the Bylaws. The number of Directors may be increased in accordance with the Bylaws but shall never be less than three. The names and addresses of the initial Directors are as follows:

CONDUCT OF CORPORATE AFFAIRS

The conduct of the affairs of the Corporation will be managed by the Board of Directors elected as provided in the bylaws of the Corporation and limited as provided herein and in the bylaws.

ARTICLE NINE

INCOME TAX

The Corporation will distribute its income for each tax year at such time and in such manner as not to become subject to the tax on undistributed income imposed by section 4942 of the Internal Revenue code or corresponding section of any future federal tax code.

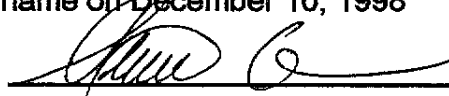
The Corporation will not engage in any act or self-dealing as defined in section 4941(D) of the Internal Revenue Code, or corresponding section of any future federal tax code.

The Corporation will not retain any excess holdings as defined in section 4943 (C) of the Internal Revenue Code, or corresponding section of any future federal tax code.

The Corporation will not make any investments in such manner as to subject it to tax under section 4944 of the Internal revenue Code, or corresponding section of any future federal tax code.

The Corporation will not make any taxable expenditures as defined in section 4945 (D) of the Internal Revenue Code, or corresponding section of any future federal tax code.

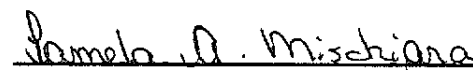
