**ARTICLES OF INCORPORATION**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

**ARTICLE I**

**NAME**

The name of the corporation shall be: **APPLIED SCHOLASTICS OF FLORIDA, INC.**

**ARTICLE II**

**PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be:

**1158 Brook Rd.  
Clearwater, Florida 33755**

**ARTICLE III**

**PURPOSES**

The specific purposes for which the corporation is organized are:

- (a) to reform education by using L. Ron Hubbard technology;
- (b) to offer management services for all applied scholastic schools, world literacy crusades and tutoring groups;
- (c) to be involved in combating illiteracy and to help children escape from a life of crime and drugs by being literate and thereby able to learn and become productive;
- (d) to perform and engage in all activities and endeavors permissible under Chapter 617 Florida Statutes and all other applicable laws of Florida;

**ARTICLE IV**

**DIRECTORS AND MANNER OF ELECTIONS**

- (a) The number of Directors constituting the initial board of Directors shall be three (3). The number of Directors may be increased or decreased in accordance with

- the By-Laws but shall never be less than three (3).
- (b) All Directors shall be elected by a majority vote of the voting members of the corporation and shall hold office for one year or until their successors are duly elected and qualified.
- (c) The voting members of the corporation shall be the persons who from time to time are members of the Board of Directors. Death, resignation or removal from office of any director as provided in the By-Laws automatically terminates his or her membership as a voting member.

#### ARTICLE V

#### AMENDMENTS TO ARTICLES OF INCORPORATION

These Articles of Incorporation may only be amended by a unanimous vote of the Board of Directors.
