Amendments adopted:

Article Two: being amended: The principal place of business shall be at 5315 SW 119th Ave., Cooper City, FL 33330. The mailing address for the corporation shall be PO Box 848428, Pembroke Pines, FL 33084

Article Three: being amended: It is the corporations intention on working closely with the Department of Children & Families Foster Care and Protective Child Care Units of Broward and Palm Beach Counties in providing abused, neglected or foster children in need with birthday gifts, cards, and cakes. These gifts will be given with the intent to build a child's self esteem, let them realize that they are cared for, and not just fall through the cracks of the system. The corporation will also provide donations of clothing, first aide, any other necessity dependant on the child's need. The criteria for obtaining donations from this corporation will be that of true need of the abused, or foster child. The corporation will work hand in hand with the child's case worker in verifying each child's circumstances and need. In working with the general public, the corporation will verify the prospective recipient is from a low income, under-privileged household. Another purpose to be conducted by the corporation will be that of fundraiser events to obtain necessary contributions to fulfill the main purpose of the corporation.

Article Eight: being amended: This corporation shall have four classes of membership: single, joint, corporate or lifetime.

Article Ten: being added: Directors of this corporation shall not receive compensation for their service as a Board Member.

Article Eleven: being added: Directors of this corporation shall not sit in or attend any meetings that are related to their compensation/salary as officer or director of said corporation. Directors shall not vote on any of their compensation for services rendered under any capacity for this organization, whether directly or indirectly.
