#### ARTICLES OF INCORPORATION

# ALLIANCE BUILDING COMMUNITY DEVELOPMENT COOPERATIVE OF JACKSONVILLE, INC. (A CORPORATION NOT FOR PROFIT)

We, the undersigned with other persons being desirous of forming a corporation for charitable and philanthropic purposes, under the provisions of chapter 617 in the Florida Statutes do agree to the following:

#### ARTICLE I

#### NAME

The name of this corporation shall be ALLIANCE BUILDING COMMUNITY DEVELOPMENT COOPERATIVE OF JACKSONVILLE, INC.

#### ARTICLE II

#### TERM OF EXISTENCE

ALLIANCE BUILDING COMMUNITY DEVELOPMENT COOPERATIVE OF JACKSONVILLE, INC. shall have perpetual existence.

#### ARTICLE III

#### **PURPOSE**

To develop, acquire, and manage an array of housing, PUD's, Assisted
Living and healthcare facilities to meet the needs of low, moderate and the general
population. To provide education, counseling and social outreach with the community.

- 1. To implement comprehensive housing programs that will include construction or rehabilitation of housing for low and moderate income persons, which will include housing for the elderly, disabled and general population.
- 2. Establish a home maintenance and monitoring program, for the purpose of maintaining the integrity of housing.
- 3. Institute a Housing Counseling program.

SECRETARY OF STATE

- Develop or rehabilitate an array of Assisted Living, Congregate Facilities, Adult Day Care, Medical Day Care, and Assisted Living programs that promote independence and "Wellness."
- 5. To house a Christian Academy and Day Care.
- 6. To house an after school program which will provide tutoring, counseling, and various other educational opportunities.

The purpose for which this corporation is organized are exclusively charitable, scientific, health, literary and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding of any future United States Internal Revenue Law(s).

#### ARTICLE IV

#### MEMBERSHIP

The qualification for members and the manner of their acceptance shall be regulated by the by-laws of this Corporation.
