The undersigned, acting as incorporator(s) of a corporation pursuant to chapter 617 of the Florida Statutes, adopt(s) the following Articles of incorporation:

**Article I**

**Name**

The name of the corporation shall be **BOCA RATON TRAVEL HOCKEY, INC.**

**Article II**

**Principal Place of Business and Mailing Address**

The principal place of business and the mailing address of this corporation shall be:

**Article III**

**Purpose**

The specific purpose for which the non-profit corporation is organized is to organize and raise money for children's roller hockey teams. 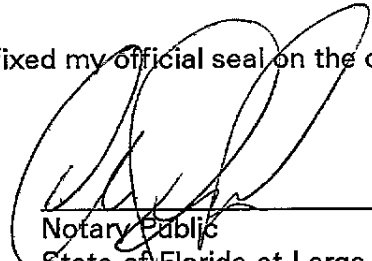
