ARTICLES OF INCORPORATION
FOR TWENTIETH CENTURY VISIONS, INC.

The undersigned incorporator, for the purposes of forming a corporation under the "Florida Not For Profit Corporation Act," §617, Florida Statutes Annotated, hereby adopt the following Articles of Incorporation.

ARTICLE I

The name of the corporation shall be: TWENTIETH CENTURY VISIONS, INC.

ARTICLE II

The corporation will exist continuously and in perpetuity.

ARTICLE III

The principal office for the transaction of business and the mailing address of this Corporation is 395 NE 154th Street, North Miami Beach, FL 33162.

ARTICLE IV

The purposes for which this Corporation is formed are exclusively for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1954, as amended (or the corresponding provision of any future United States Internal Revenue law) including for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or the corresponding sections of any future federal tax code.

ARTICLE V

No substantial part of the activities of the Corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation and the Corporation shall not participate or intervene in any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these Articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501(c)(3) of The Internal Revenue Code of 1954 or any corresponding provision of any future United States Internal Revenue Law.

ARTICLE VI

The Corporation is formed solely for charitable and educational purposes. The Corporation is not organized, nor shall it be operated for the purpose of generating pecuniary gain or profit, and it will not distribute any gains, profits, or dividends to the Directors, Officer, or Members thereof, or to any individual, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payment and distribution in furtherance of its specific and primary purposes. The property, assets, profits, and net income of the Corporation are irrevocably dedicated to charitable and educational purposes, and no part of the profit or net income of the Corporation shall inure to the benefit of any individual.

ARTICLE VII

Upon winding up and dissolution of the Corporation, the assets of the Corporation remaining after payment of, or provision for payment of, all debts and liabilities of the Corporation, shall be distributed to Church of the First Born, Inc in Miami, Florida conditioned upon said church maintaining exempt status under Section 501(c)(3) of the Internal Revenue Code of 1954 and if such exempt status has not been maintained, then to another organization which is exempt under Section 501(c)(3) of the Internal Revenue Code of 1954 and used exclusively to accomplish the primary purposes for which this Corporation is organized. If the Corporation holds any assets in trust, such assets shall be disposed of in such manner as may be directed by decree of the Circuit Court of the county in which the Corporation's principal office is located, but such property shall only be distributed to an organization exempt from Federal Taxation under Section 501(c)(3) of the Internal Revenue Code of 1954.

ARTICLE VIII

The names and addresses of the initial directors are: Aston Goldson, 3500 NW 38th Terrace, Lauderdale Lakes, FL 33309; Byron Williams, 21011 NE 13th Place, North Miami Beach, FL 33179; Donald F. Clarke, 395 NE 154th Street, North Miami Beach, FL 33162. The method of choosing directors shall be stated in the Bylaws.
