The undersigned incorporator, for the purposes of forming a corporation under the "Florida Not For Profit Corporation Ret," 5617. Florida Statutes Annotated, hereby adopt the following Articles of Incorporation.

ARTICLE I

The name of the corporation shall be: TWENTIETH CENTURY VISIONS, INC.

ARTICLE II

The corporation will exist continuously and in perpetuity.

ARTICLE III

The principal office for the transaction of business and the mailing address of this Corporation is 395 NE 154th Street, North Miami Beach, FL 33162.

ARTICLE IV

The purposes for which this Corporation is formed are exclusively for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1954, as amended (or the corresponding provision of any future United States Internal Revenue law) including for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or the corresponding sections of any future federal tax code.

ARTICLE V

ARTICLE VI

The Corporation is formed solely for charitable and advestional purposes. The Corporation is not organized, nor shall it be operated for the purpose of generating pecuniary gain or profit, and it will not distribute any gains, profits, or dividends to the Directors. If the Corporation holds any assets in trust, such assets shall be disposed of in such manner as may be directed by decree of the Circuit Court of the county in which the Corporation's principal office is located, but such property shall only be distributed to an organization exempt from Federal Taxation under Section 501(c)(3) of the Internal Revenue Code of 1954.
