ARTICLES OF INCORPORATION

OF

MIRACLE KIDS LEARNING CENTER, INC.

ARTICLE I

OINTSION OF STATEONS FILED STATEONS ON SECRET PROPERTY OF STATEONS

NAME

The name of the corporation shall be:

MIRACLE KIDS LEARNING CENTER, INC.

Its business shall be carried on in the State of Florida, in the United States of America and elsewhere, as may be authorized by its Board of Directors.

ARTICLE II

NATURE OF BUSINESS

The business of the corporation shall be: Tutoring and education of children, and all manner of services in connection therewith. It shall be operated as a not-for-profit corporation.

In addition, the corporation may engage in or transact any or all activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE III

PRINCIPAL OFFICE

The principal office of the corporation shall be located at:

ARTICLE IV

INITIAL BOARD OF DIRECTORS

The business of the corporation shall be managed by a Board of Directors consisting of not less than three (3) nor more than five (5) directors. The number of directors may be increased or diminished from time to time in accordance with the By-Laws, which shall specifically provide for increases or decreases in the number of directors without the necessity of amending these Articles of Incorporation, but in no event shall the corporation have fewer than three (3) directors. All directors shall be elected as set forth in the By-Laws.

ARTICLE V

BY-LAWS

The Board of Directors may adopt, amend, alter or repeal By-Laws of the corporation. The By-Laws may contain any provisions for the regulation or management of the affairs of the corporation not inconsistent with law or these Articles of Incorporation.

ARTICLE VI

AMENDMENT

These Articles of Incorporation may be amended or repealed in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed by them to the members, and ratified by an affirmative vote of a majority of the members entitled to vote thereon, unless all of the directors and all of the members sign a written statement manifesting their intentions that a certain amendment to these Articles of Incorporation should be adopted.

ARTICLE VII

INDEMNIFICATION OF OFFICERS, DIRECTORS, EMPLOYEES AND AGENTS

The corporation shall indemnify any director or officer, and shall have the power to indemnify any employee, agent or other person who was or is a party or is threatened to be made a party to any threatened, pending or completed action, suit or proceeding, whether civil, criminal, administrative or investigative, by reason of the fact that he/she was or is acting on behalf of, or at the request of the corporation. Such indemnification may take the form

of court costs, attorneys' fees or other expenses incurred by such person involved in such action, suit or proceeding.

ARTICLE VIII

ACTION WITHOUT MEETINGS

Any action that may be taken at a meeting of the members of the corporation may be taken without a meeting, provided that consent in writing setting forth the action shall be signed by all, but not less than all, of the members of the corporation then entitled to vote on the action. Such written consent shall be filed with the secretary of the corporation and shall have the same effect as a unanimous vote at a membership meeting. If all of the directors, severally and collectively, shall likewise consent in writing to any action taken or to be taken by the corporation, and if the writing evidencing their consents are filed with the secretary of the corporation, the action shall be as valid as though it was authorized at a meeting of the Board of Directors.

ARTICLE IX
