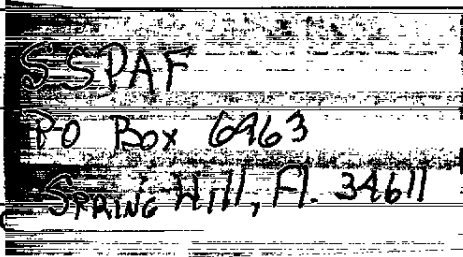

ARTICLES OF INCORPORATION

A Florida Nonprofit Corporation

ARTICLE 1.

The name of the corporation is Socializing Single Parents and Friends, Inc..

ARTICLE 2.

This corporation shall exist perpetually unless dissolved according to Florida law.

ARTICLE 3.

The principal place of business and is: P.O. Box 6963, Spring Hill, FL 34611 and the mailing address is: .

ARTICLE 4.

This Corporation is a not-for-profit corporation organized under Chapter - 617, Florida Statutes. It is not organized for the private gain of any person. The specific purposes of this corporation is to organize, promote and hold meetings for Single Parents and Friends.

To all rights and powers conferred by the laws of the state of Florida required of a non profit corporation. Provided, that the corporation does not engage in any action which is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code and no part of the net earnings of the Corporation will inure to the benefit of or be distributable to its members, directors, but the Corporation may have the power and be authorized to pay reasonable compensation to the aforesaid persons for their services rendered.

ARTICLE 5.

Non Stock Basis, The Corporation shall be operated and is organized on a non-stock basis as required by the Florida Not For Profit Corporation Act, and will not have the power to issue shares of any type or class of stock, but may issue membership certificates if provided by the by laws of the corporation.

ARTICLE 6.

ARTICLE 7.

The initial Board of Directors shall have FOUR (4) member(s). The number of directors may be raised or lowered by amendments of the bylaws of the corporation but shall never be less than three.
