ARTICLES OF INCORPORATION

The undersigned, acting as incorporator(s) of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation shall be:

The West Jupiter Collaborative, Inc.

ARTICLE II - PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business and mailing address of the corporation shall be

ARTICLE III - PURPOSES

To preserve community history and heritage; the conservation of environmentally sensitive lands in the area; promoting family and neighborhood values; foster and generate stakeholders within the community; develop strengths, overcome weaknesses; and develop and promote residential, business and economic opportunities in the Limestone Creek community.

ARTICLE IV - MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is as follows:

Elective Officers:

The elective officers shall consist of two (2) Co-Chairpersons, Treasurer and Secretary, all of whom shall serve for a period of two (2) years or until their successors are duly elected.

The initial Board of Directors shall serve an initial first term of three years. Thereafter, all terms shall be two years, with Directors being elected in the following manner:

- (a) In order to maintain continuity on the Board of Directors, one-third (1/3) of the Directors shall be elected each year.
- (b) At the inception and adoption of these articles, one-third (1/3) of the directors shall be elected for a period of three years; one-third (1/3) for a period of two (2) years; and one-third (1/3) for a period of one (1) year.
- (c) Thereafter, one-third (1/3) of all directors shall be elected for a period of three (3) years at the annual meeting.

The By-Laws shall outline details on the holding of elections, membership of the organization, eligibility for Directors, etc.

ARTICLE V - LIMITATION OF CORPORATE POWERS

The corporate powers of this corporation are as provided in Section 617.0302, Florida Statutes, unless limited as follows:
