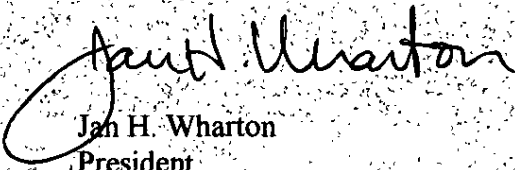
Dear Stacy:
