

ARTICLES OF INCORPORATION

The undersigned incorporate, for the purpose of forming a corporation under the Florida not-for-profit Corporation Act, hereby adopt(s) the following Articles of Incorporation.

Article I NAME

The name of the corporation shall be: VISION BEFORE VICTORY MINISTRY, INCORPORATED.

Article II PRINCIPLE OFFICE

The principle place of business and mailing address of this corporation shall be: 3917 North Tampa Street, Tampa, Florida 33603. Mailing Address is P.O. Box 15186 Tampa, Florida 33684.

Article III PURPOSE(S)

The specific purpose(s) for which the corporation is organized is (are): To provide Counseling, mentoring, employment, and other services that is needed along with speaking engagements to at-risk youth, offenders and the welfare recipients regardless of age, sex, religion, and race, so that their lives will be restored and changed through the word.

<u>Article IV</u> <u>MANNER OF ELECTION OF DIRECTORS</u>

The manner in which the directors are elected or appointed will be an advertisement in the local community for election process. The board will consist of no more than seven (7). Each will be interviewed to see if their VISION is in line with the Corporation. A one year commitment will be required before re-election.

Amendment to the Articles of Incorporation

- A. The purposes for which the corporation is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of section 501(c)(3) of the internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.
- B. Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.
- C. In the event of dissolution, the residual assets of the organization will be turn over to one or more organization which themselves are exempt as organizations described in sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1986 or corresponding section of any prior or future Internal Revenue Code, or to the Federal, State, or local government for exclusive public purpose.
